We sincerely regret the inconvenience caused to you by the corporate reorganization proceedings.

With respect to the following bonds (collectively referred to as the "Bonds") issued by Elpida Memory, Inc. ("Elpida"), we are asking you as the holder of the Bonds (the "Bondholders") to provide us with your information as announced on our website (Please see "Request for Information on Straight Bondholders" dated March 23, 2012). As the Bonds are issued under the Book-Entry Transfer System for Corporate Bonds operated by Japan Securities Depository Center, Inc. (the "Book-Entry Transfer System"), such request is also being made through Japan Securities Depository Center, Inc. and account management institutions.

Currently, we are sending the Notice on Court Decision to Commence Corporate Reorganization Proceedings, the Proof of Claims form, etc., to the Bondholders who have notified contact information to us and we are also receiving the completed Proofs of Claims from them. However, under the Book-Entry Transfer System, we cannot check if the Bondholders who submitted the Proofs of Claims actually hold the Bonds described therein. Moreover, we cannot obtain any information relating to transfer of the Bonds.
